

LIST OF TOOLS AND INITIATIVES FEATURING BUSINESS AND HUMAN RIGHTS INDICATORS

The project

Measuring Business & Human Rights (MB&HR) is a research project that aims to advance the capacity of business managers and corporate stakeholders to assess the extent to which companies meet their responsibility to respect human rights. In particular, the project will:

- explore the most pressing normative, methodological, practical and political challenges when producing business and human rights indicators, and suggest realistic strategies to create valid measurement tools;
- offer a transparent and comprehensive database of information on existing organizations, tools and initiatives using business and human rights indicators;
- host a blog as a public forum for an open discussion on how to improve the way corporate respect for human rights is measured.

Guidance note on the list of tools and initiatives using business and human rights indicators¹

The tables below list the most relevant tools and initiatives that feature business and human rights indicators. The proliferation of ratings and indices that measure respect for human rights by corporations underlines the relevance of MB&HR's purpose to enhance the transparency of such initiatives and trigger a public debate on how business and human rights indicators should be produced.

The tables are divided into six categories: (1) management tools; (2) reporting frameworks; (3) sustainability investment indices; (4) sustainability ratings; (5) sustainability standards, multi-stakeholder initiatives and certification schemes; and (6) human rights impact assessment tools. The distinction between the categories may not always be clear-cut. Nevertheless, the categorization is helpful to indicate that all corporate stakeholders have shown interest, and have been involved in, the production of business and human rights indicators.

The list will be used as a reference point for the next step of the project, namely, the creation of a "summary card" for each tool and initiative, describing its main features, strengths and weaknesses. The aim is to increase transparency, avoid duplication of efforts, prevent mistakes and collect best practices.

It is important to emphasise that MB&HR will also have due regard to the most prominent measurement tools and initiatives that focus on general sustainability issues but do not include business and human rights indicators. While these tools and initiatives will not be the object of specific analysis (at least in the initial phase of the project), they will be taken into consideration in order to distil best practices.
