## Subject: Call for applications for five vacancies of special procedure mandate holders to be appointed at the 38<sup>th</sup> session of the Human Rights Council <sup>1</sup>

The Secretariat of the Human Rights Council presents its compliments to all Permanent Missions to the United Nations Office at Geneva, international organizations or their offices, national institutions, non-governmental organizations and other human rights bodies, and has the honour to inform them that the following five mandate holders are to be appointed at the thirty-eighth session of the Council (18 June to 6 July 2018):

- 1. Special Rapporteur on the issue of human rights obligations relating to the enjoyment of a safe, clean, healthy and sustainable environment [HRC res. 28/11]
- 2. Special Rapporteur on the situation of human rights in the Islamic Republic of Iran [HRC res. 34/23]
- 3. Working Group on the issue of human rights and transnational corporations and other business enterprises, member from African States [HRC res. 35/7]
- 4. Working Group on the issue of human rights and transnational corporations and other business enterprises, member from Eastern European States [HRC res. 35/7]
- 5. Working Group on the use of mercenaries as a means of violating human rights and impeding the exercise of the right of peoples to self-determination, member from Western European and other States [HRC res. 33/4]

Individual applications, including a motivation letter, must be submitted and received by <u>4 May 2018 (12 noon Greenwich Mean Time / GMT)</u> through the on-line application procedure, which consists of (1) an online survey and (2) an application form in Word format.
