# 9.1 September 4

9.1.1 GSBI-SBGTS along with DPP.GSBI visited to the National Human Rights Commission ("NHRC") to submit complaints directly related to the issue that occurred in PDK (Ref. G12-2 Page 1 modified).

## 9.2 September 6

- 9.2.1 NHRC has issued a letter addressed to President of PDK, with number: 1,799/K/PMT/IX/2012 about asking clarification and insistence to stop intimidation action (Ref. G12-2 Page 2).
- 9.2.2 Where the parities of PDK within 14 days should explain in terms of a. the use of the police and b. the PDK's actions to intimidation and pressure on workers who joined in the strike to resign (Ref. G12-2 Page 2 modified).
- 9.2.3 PDK received the NHRC letter 1,799/K/PMT/IX/2012, but received on 27<sup>th</sup> September 2012(Ref. PDK12-3 Page 1).
- 9.2.4 What the NHRC letter asked PDK to explain within 14 days is the right content of the letter what PDK had received (Ref. PDK12-3 Page 1 modified).

### 9.3 September 12

- 9.3.1 SGBT-GSBI member reduces down to 10 (Ref. PDK12-2 Page 1 modified).
- 9.3.2 Total number of employee of PDK dated September 12, 2012 is 2402 persons and a detail of association is SGBT-GSBI: 10, SPN: 153, SPI: 1522, non-member: 717 (Ref. PDK12-2 Page 1 modified).

### 9.4 September 19

- 9.4.1 NHRC has issued a letter addressed to President of PDK, with number: 1,867/K/PMT/IX/2012 about insistence to stop intimidation action and paying wages (Ref. G12-2 Page 2).
- 9.4.2 Where the contents of the letter was a. urge PDK to pay workers' rights and wages that have not been given until any a legal decision remains and pay the back payment of wages since January to March 2012 who have not been paid (Ref. G12-2 Page 2 modified).



9.4.3 Where the contents of the letter was c. delivering answers and the results of follow-up letter to NHRC within 14 (fourteen) working days after PDK received a letter.

9.4.4 PDK received the NHRC letter 1,867/K/PMT/IX/2012 (Ref. PDK12-3 Page 1).

9.4.5 PDK received the NHRC letter 1,867/K/PMT/IX/2012 on September 27<sup>th</sup> together with the NHRC letter dated September 6, 2012 1,799/K/PMT/IX/2012 (Ref. PDK12-3 Page 1).

### 10. October 2012

#### 10.1 October 5

9.5.1 DPP.GSBI has pressed the police to release Omih under the support of various parties including DPR.RI IX Commission, NHRC, the Ministry of Women's Empowerment, Ministry of Manpower, and that has urged PDK to immediately revoke their report to the Police Resort (Ref. G12-2 Page 3).

## 10.2 October 8

10.2.1 GSBI, SBGTS-GSBI have attended the Public Hearing organized by the Commission IX of Parliament House ("Manpower Commission"), which was also attended by the Director General of Industrial Relation Settlement of Ministry of Manpower and the Public Hearing held by the Manpower Commission was conducted after receiving a complaint submitted by SBGTS-GSBI (Ref. G12-2 Page 3).

### 10.3 October 10

10.3.1 The Manpower Commission visited PDK and the Chairperson of Commission urged PDK to rehire immediately unconditional about 1.300 workers who unilateral dismissal and pay rights that have not been received since declared unilateral layoffs, and urged PDK to withdraw their report to the police resort on behalf Omih (Ref. G12-2 Page 3-4).

10.3.2 The result is that the Manpower Commission urges everyone attend the meeting/mediation to make small team consist of Labor department, PDK and



SBGTS-GSBI (Ref. PDK12-3 Page 3).

10.3.3 PDK agreed on involved in the small team as described on the above to seek opportunity to solve the case (Ref. PDK12-3 Page 3).

The above are the Undisputed Facts (from September 1, 2012 to October 31, 2012) proposed. Please note that we have made modifications in case that the parties have different opinions and/or views at that points.

If you need the original documents of Arguments to check details, please do not hesitate to request us.

If you find any mistypes or misunderstanding on "your own part", please let us know. If we do not receive any objection or response on "your own part" by November 19, 2015, we will construe "your own part" as Undisputed Facts.

We will send the Open Letter of Inquiry based on the Undisputed Facts and our consideration soon.
